



The History of April Fools'

What's up with the funniest day of the year?

Every year, cultures all around the world celebrate a spring tradition where friends, neighbors, classmates, and anyone else who wants to can play pranks and tell jokes to their heart's delight. The origins of April Fools' Day, sometimes referred to as "All Fools Day" can be a little blurry, but most historians point to the Greco-Roman festival known as

Hilaria where people celebrated the mother of gods, Cybele.

The people would celebrate on March 25 by dressing up, throwing parades, and telling jokes.

They would celebrate on this day because the Julian calendar recognized it as the beginning of the year, marking a sort of New Year's celebration until the Gregorian calendar changed New Year's to January.

Aside from a historical perspective, others believe that the day celebrating craziness and hilarity may just point to the crazy nature of spring weather and the celebration of the harsh winter coming to and end.

Some of the more local traditions can vary from place to place. In Ireland and Scotland it was traditional to entrust the victim with an "important letter" to be given to a person of the pranksters choice. That person would then ask the victim to take it to someone else, and so on until the messenger got too curious to resist. The letter, when finally opened contained

the words "send the fool further." In Italy, France, Belgium, The Netherlands, and French-speaking areas of Switzerland and Canada, the April 1 tradition is often known as "April fish". This entails attempting to attach a paper fish to the victim's back without being noticed.

As well as people playing pranks on one another on April Fools' Day, elaborate hoaxes have appeared on radio and TV stations,

1) Minion Mic Drop

Google, the website everyone knows and loves, wanted to partake in April Fools by playing a prank on its users. Users found a new feature added to Google Mail on the occasion and received the option to select an icon with the phrase "send +" and a tiny picture of a falling microphone when composing an email. Once selecting the icon, a gif of a minion, a cartoon character, doing a mic drop was sent to the listed receiver and the email thread was automatically muted. Unfortunately, the "send + [mic drop]" icon replaced Google's usual "send + archive" button. Regular users of the original icon would click the new icon with the intention of sending and email and archiving it, but users wound up attaching mic drop gifs where they shouldn't have been. There was one case where a writer lost his job all because he fell victim to Google's April Fools prank. After multiple complaints, the company issued an apology saying, "Well, it looks like we pranked ourselves this year. Due to a bug, the Mic Drop feature inadvertently caused more headaches than laughs. We're truly sorry. The feature has been turned off."

2) April Fools News

In 1980, Homer Cilley, a Boston, Massachusetts news producer, decided to take part in April Fools' Day by broadcasting a special announcement. The station claimed that in Milton, Massachusetts, the Great Blue Hill was on the verge of eruption. They described the "volcano" releasing lava and flames, and one can imagine how this fake warning stirred nerves and panic in locals. The station even went as far as to add fake warning quotes from then-President Jimmy Carter. They also displayed video footage of Mount Saint Helens, which was a real erupting volcano, claiming it was the hill. The broadcast closed out with a card that said, "April Fool." However, Cilley's bosses weren't amused and decided to fire him immediately after the broadcast.

On April 1, 2015, the Manchester police department in the United Kingdom put out a tweet to participate in the April Fools spirit. The tweet states, "Know someone in prison? You can get them released early by voting for them on here. The prisoners with the most votes also wins a holiday." Not everyone found it to be funny. In response to public feedback, the police department also tweeted that the act was "a goodwill gesture from the politicians." The tweets received mixed emotions all over social media. 

Humor's Hysterical History

A retrospective on society's funny bone

Society created a holiday on the first of April dedicated to playing practical jokes on one another. From small, foreign scriptures to a whole dedicated genre in entertainment known as comedy, humor has been a fixture in society for centuries. Many have used it as a means of getting a smile on their face or on someone else's. However, not many may know how society grew to be so funny. The earliest form taught in school would be some of the comedic work of Shakespeare back in the 16th century such as Much Ado About Nothing and A Midsummer Night's Dream. Despite this, humor isn't one of those things that just happened within society. Like many things back then, such as farming, comedy has a long, complex, and world changing history. To truly figure out where and when humor was born, one would have to go back to 1900 B.C. Certain types of humor have been around for a long time, but the longest standing type just so happens to be toilet humor. Toilet humor is a type of comedy that often refers to bodily functions such as farting, and often mixed reputation. Despite this, one could say that comedy was built around such toilet humor. The world's oldest joke originated within Sumer, Mesopotamia, modernday Southern Iraq. According to Oldest.org, it was found within the Sumerian Proverb Collection in Verse 1.12-1.13. The joke states the following: "Something which has never occurred since time immemorial: a young woman did not fart in her husband's lap." The Sumerian Proverb Collection was also known as the Instructions of Shuruppak, and it was a book full of advice given to his son, Ziusudra. Whether this joke was just a misguided form of advice or a genuine attempt at humor is

Moving forward in history, although the aforementioned Shake-speare cannot be credited for the invention of the joke, he can be credited by many for one certain type of joke: the knock-knock joke is a very popular joke with a simple

premise of a person walking towards a door, knocking on said door, and another person inside the premises answers by asking who showed up. The formula varies from there, but these components are the basis, and it is said that these components originated within Macbeth. In Act 2, Scene 3 of Macbeth, a porter wakes up from being drunk to someone knocking at the door of Macbeth and his wife. The porter responds to this by saying "Knock, knock, knock! Who's there, i' th' name of Beelzebub?" The joke would not reach popularity until the year 1936, three hundred and thirty years after Shakespeare wrote Macbeth. Enotes.com stated that on the day of August 19th, Variety reported on a "knock knock craze." On November 14th, "a radio performer named Wee Georgie Wood set England afire with 'Knock Knock' jokes." The joke was not received well at first, but it would eventually catch on and give prominence to a fresh type of joke. The rest, as humanity knows it, is history. Some jokes are just objectively too funny not to be told multiple times. These type of jokes get inducted into a collection of jokes appropriately named the joke book. Philogelos, a collection of some of the world's oldest jokes, was published in 1965. From Greek to English, the title roughly means "The Laughter Lover." The collection has jokes that were made and assembled centuries older than the publication date. John T. Quinn of Diotima established that the 265 joke collection was "likely made in the fourth or fifth century CE," around 1600 years before publication in the twentieth century, and this would make sense because the jokes had been written in Greek and translated to English. The jokes had also been split into multiple different categories ranging from one about intellectuals to one about people that are incompetent. One of the 265 jokes in the collection goes as follows: "An intellectual came to check in on a friend who was seriously ill. When the man's wife said that he had 'departed,' the intellectual replied: 'When he arrives back,

people around the globe. In the modern day, comedy can be described as a professional entertainment program of some sort that has the goal of making people laugh. The original conception of comedy came from Aristotle, a great intellectual figure within history. According to Cyrus Henry Hoy of Britannica.com, "the comic artist's purpose is to hold a mirror up to society to reflect its follies and vices." A French philosopher, Henri Bergson, added onto this theory by noting how laughter returns the main character "into conformity with his society." In short, a comedy in the modern day is a lighthearted form of social commentary that can also be used to entertain an audience rather than frighten the audience about the future. At first, comedy was expressed through plays and literature, but throughout the years, stand up comedy and movies have evolved the term. Both of these things originated within the 1800s. Eddie Tafoya stated in his book, The Legacy of the Wisecrack that a vaudeville performer named Charley Case was the first person within the time of the 1880s or 1890s to perform comedic monologues on the vaudeville stage without anything extra. This means he had no props or costumes. Charley Case only had his humor and his comedic timing, and it worked out for his As for the first comedic film, that

accolade goes to the French film by Lumière named L'Arroseur Arrosé, otherwise known as The Sprinkler Sprinkled in English. The plot revolves around a gardener watering his flowers and a mischievous boy messing with his water hose. When the same boy splashed water from the hose at the man's face, the man chased the boy down in order to punish him. The boy then ran off and the gardener went about his business as usual. This short film could be considered as the grandfather of slapstick. Had comedy films never caught on in 1895, the world would have possibly never had comedy films such as Shaun of the Dead, Dumb and Dumber, or anything from the Monty Python franchise of films. Laughter is one of the most

positively contagious concepts in this world. There's nothing like a good joke to help make a frown go upside down. The world is an often serious place, and humor helps build the balance between seriousness and silliness. Spend this April 1st putting a harmless smile on someone's face. It will make their life better in the long run.

Being Black in America

First-hand experiences

Racism is a sensitive topic that has been a part of conversation for centuries. Racism has become a hot topic again in the United States, especially among people of color. There have been many protests and marches, especially by the black community, asking for people to understand them, as well as treat them the same as everyone else. The problem is that a lot of people, especially white people, do not completely understand discrimination based on one's race, which can make it hard to empathize with black people and all other people of color. Without firsthand experience, people cannot put themselves in a place to fully comprehend the severity of the

Hearing and reading about this issue everywhere I go has left me thinking about my own experiences as a black woman in America. I found that I could not relate or empathize as much with my fellow black American peers because I did not fit into the bubble of being "African American." Let me explain.

Coming from Jamaica, which is predominantly black, all you can do is hear about racism because it is not an issue that many Jamaicans are exposed to or even witness in their own country. Even with the non-black people in Jamaica, race was just never a thing that was an issue amongst Caribbean people. But sometimes, the lack of experience brings ignorance, which can create a lack of sensitivity to the issue. Don't get me wrong though, I've always been able to understand that the

issues people face because of their race/skin color is appalling, especially for the times we live in, but I was just never able to fully grasp what that really meant. Well, that was until I left out of the comfort of my little Columbia neighborhood to an entirely new state.

It was the summer of 2016 and I decided to go on a mission trip with my church. I had been anticipating that trip for a whole year, and it had finally arrived. We decided to drive all the way to Michigan, and driving usually calls for a lot of quick stops. One stop in particular that I remember to this day was when we finally arrived in Michigan. We were an hour away from our destination and my pastor took my group of black friends and I to the side in order to warn us that racism was still very prevalent in that part of town. He made sure that we were aware that we needed to pay attention to our surroundings at all times. I remember being absolutely horrified and scared after speaking with him. Thankfully, we were able to do what we needed to, and leave, all while being unharmed.

After arriving at our destination, we met another youth group, coming from central Michigan, who stated that their town was a headquarter for the Ku Klux Klan (KKK). I'm not sure if they were still an active group, but just the mere thought that it was a commonly known fact that the town held a group that promoted racism, was very shocking to me. Overall, the trip was a success even though these events took place.

The severity of the issue of racism hadn't really fully dawned on me until I was put in a position

that compromised my safety. That trip was definitely a wake up call for me because it strengthened my understanding of the subject as a whole. Now, I definitely don't believe that having to experience situations like these is something that everyone should undergo, but it was definitely something that made me less ignorant to the subject as whole. Even though this isn't a competition, I realize that my slight experience could not even compare to what other black people have experienced or gone through in their lives. That being said, there is value to what I endured because learning and understanding racism is a great way to allow the world to progress as a whole.

Coming back from my trip, I was enlightened because I finally got an understanding of what my peers were searching/asking for: someone to understand their perspective. It was not just about reading posts on the internet or listening to the news about the situation, I was now able to have a larger connection to the protesters and marchers. Even though the way in which I was able to gauge an understanding of the topic was not the best, it allowed me to empathize more with my peers for that reason. Sometimes, the reason others may not understand where you are coming from is because they have not been in a situation to fully comprehend the complexity of your situation. And sometimes, being placed in a situation is the only way for someone to really understand how you are feeling. This does not mean that others should not try to sympathize with you as best as they can because that's where the line between ignorance and arrogance is drawn.

Why body shaming does not help people

Body shaming has been a hot topic in recent years, with many high fashion brands and clothing stores beginning to use plus size models in their promotion, selling wider varieties of sizes, and including messages about self acceptance and diversity in their advertisements and campaigns. This shift in marketing and business has been met with positivity and praise.

Body shaming is when someone makes negative comments or actions towards you for your appearance. It can be anything from calling your classmate ugly to denying your child a snack. It happens to people daily at home, school, work, and even when you're simply crossing the street.

Recently many people have come out of the woodwork to criticize the anti-body shaming movement. Why? Well, many people feel that things like body shaming is deserved by people of certain body types, and that it helps people become healthier. People feel that bullying 'fat'

people will motivate them to lose weight, thus making them healthier. Does this theory hold up? Spoiler alert: The answer's

The theory has one very obvious, glaring problem. How can one even truly tell when someone is fat? How can one tell if someone is unhealthy? People often like to point at images of morbidly obese people, but forget that the standard healthy body changes depending on who you ask. A morbidly obese person is the extreme most people can agree on, but look at the standards of beauty we have now and how they've changed overtime. Nowadays, even a shred of stomach fat is undesirable, and yet look at women of the past like Marilyn Monroe. Yes, she was considered beautiful by many, but she didn't have a flat stomach. Would she have been considered unhealthy if she lived in the modern era? I'm not bringing this up to make the standard 'plus size people are good looking too' argument. I'm bringing it up to illustrate a point. The guy who stares at you across the street, or that one rude classmate in school. or the least favorite aunt are not

doctors. You can rarely tell just by looking at someone if they're overweight or not. You'd need to look at their genetics, see if they have any conditions, and even calculate their body mass index (Even then, previous phys ed teachers of mine have said the BMI system is outdated). How can you tell if someone is fat?

This leads to people who aren't anywhere near overweight thinking that they're obese. When someone of a normal weight begins to rapidly lose weight they put themselves in danger. This is one way that body shaming can negatively affect one's health. Someone who is healthy but is considered to be fat by a narrow minded person could end up becoming underweight as a result.

The truth of the matter is that even if someone was overweight, body shaming is not going to help them get healthier. Often times, it even causes them to gain weight. But wait! Some say if these people were truly hurt at all by what people said about them, they'd just lose the weight! Clearly body shaming doesn't really affect them that much! Well. hypothetical opposition, body

shaming actually can make people gain weight.

Eliza Kingsford, a psychotherapist who focuses on body image, says that body shaming doesn't cause people to become healthier as much as it makes them less healthy. Imagine you're working really hard at a diet/exercise program, but your body just isn't changing shape fast enough. "How frustrating and hopeless that might feel," Kingsford says. "Add to that the pressure you feel because people are commenting about your shape. This can lead to all kinds of detrimental feelings and actions, everything from giving up on your program to turning to unhealthy behaviors." The aforementioned unhealthy behaviors could include things like binge eating, eating more, unhealthy behaviors, or shutting down and avoiding exercise altogether. Body shaming can also cause starvation and anorexia, but people usually don't notice or mind when someone loses weight in an unhealthy fashion. Why is this?

Body shaming isn't about health, it's about attractiveness. What's considered beautiful depends on time period, location, personal preference, etc. But right now being on the heavier side makes you unattractive, especially if you have more weight in the stomach region. You can be skinny and still be considered beautiful, but being heavier instantly makes a lot of people unattracted to you. You don't have to be attracted to every type of person, but there's a problem when you ridicule, and bully people who don't match your 'looking for' description on OKCupid. You don't get to demand someone to change themselves to fit into your idea of good looking, especially in situations where you don't know if they're unhealthy or not.

This is why body shaming

affects women more than it does men. According Dr. Rebecca Puhl of the University of Connecticut, women can start experiencing fat shaming when they just start to become overweight, while men in general don't face criticism until they start to become obese. Even among obese people, obese women experience three times more shaming than men. It's almost as if women are being punished simply because they aren't attractive enough, and that they owe it to society to look as beautiful as possible.

Here's another wild reason not to body shame that's totally out of this world: body shaming isn't a nice thing to do. Put yourself in the shoes of a high schooler out there who, for whatever reason, is 'chubby.' Imagine them getting stared at in the hallway, getting teased by their P.E. teacher, getting rude comments and messages online, coming home and getting lectured by family about how their appearance is going to make their life miserable if they don't change it in time, all while having to deal with school stress, maybe even a job too. Then, you come in. Maybe you're a stranger on the street or someone on their bus, or maybe you're even their friend. Whatever you're about to say, they've heard it before, and they'll probably hear it again tomorrow. What you say might not give them an eating disorder or depression, but it can still seriously hurt their feelings, which is wrong.

Even with all of the naysayers, people are waking up and realizing that body shaming isn't okay, which is good. More and more people are joining the conversation and more people are showing compassion towards people who have been affected by it.
